

AMMENDED MINUTES FROM THE OCTOBER 17, 2024 MEETING OF THE GREEN SPRING COMMISSION

The meeting was called to order at 7:07pm by Mayor John Morton. In attendance were City Commissioners Stuart Ries, Trevor Cravens, and Chris von Allmen. City Attorney Chip Hayward, City Clerk Caryl Conklin, and City Resident Mike Faith were also present. Commissioner Josh Combs was absent.

Commissioner Ries moved to approve the September meeting minutes, and Commissioner von Allmen seconded the motion. September meeting minutes were approved unanimously.

The Security Report was emailed and contained no significant events.

BEAUTIFICATION, Commissioner Chris von Allmen

FINANCE, Commissioner Stuart Ries

Income for September was \$2,660.85. Expenses for September were \$21,842.05. Major September expenses included Trash Collection (\$7,935.00) and 50th Anniversary Celebration (\$4,146.98).

A donation was made to the Alzheimer's Association in memory of Alyce Huff. Alyce was the wife of long time Green Spring Mayor Bill Huff.
